LLPOA Board Elections

Elections will be held at the June 28, 2022 Annual Meeting to fill expiring seats held by Jeff Banaszynski, Mike Bartlett, Tom Maliszewski, Chris Tanana and Marc Van Hoogstraat. Nominations will be accepted at the meeting followed by a member vote. Nominees need to be property owners of record on Lakeville Lake.

Member Vote to Reduce Paper Mailings of Newsletters and Notices.

The LLPOA Board has approved a member vote on a proposal to selectively discontinue hard copy distribution and mailing of association newsletters and notices in favor of electronic distributions via e-mail consistent with the current By-Laws. The vote will be held at the June 28, 2022 Annual Meeting.

If you cannot attend the meeting and want your vote counted, valid proxies may be submitted to the Secretary no later than 10:00 p.m. on June 27, 2022. Lake Monitoring

Lakeville Lake continues to participate in the Cooperative Lakes Monitoring Program (CLMP) run by the Michigan State University Extension Program in cooperation with EGLE. Lakeville Lake collects samples and data for phosphorous, water clarity, chlorophyll and dissolved oxygen. Samples and data are submitted to EGLE for analysis to determine overall lake health and monitor trends from year to year. Lakeville Lake is considered to be in good condition. Results are summarized and published annually. The report for 2021 is posted on our web-site at www.lakevillelake.org under the 'Lake Monitoring' tab or can be found on the CLMP web-site at micorps.net under the 'Feature Content' tab. Data can be viewed for Michigan Lakes in total or for individual lakes. Additionally, past year's data can be viewed.

Weed Harvesting Program for 2022

Savin Lake Services surveyed the lake on May 11th and found weed growth to be running a couple weeks behind normal activity. As a result, the planned weed harvesting program start has been delayed. Current plans include season prep work the week of June 6 with equipment set-up and harvester launch around June 13th. Two employees are lined up and normal harvesting activities will begin the week of June 13th. Thanks to Eric Lundy, the North weed off-load site used the last four years is available again this year. We don't currently have an off-load site in the South end of the lake and will probably lose access to the North site in a year or so. Off-load site options are being sought. Without an off-load site, we will not be able to run the program.

Marine Patrol for 2022

Donations have been collected to fund the Marine Patrol for 2022 at levels consistent with the past couple years. A fund raiser was held in May at the Celtic Knot with 15% of the day's proceeds donated. Those proceeds when combined with funds left over from last year, new contributions from individuals including property owners and Smith's marina slip renters and potential Sheriff reimbursements from the Township should result in enough money to support this year's patrol. Our thanks to LLPOA Board member, Gerard Wrobel, for coordinating the donations and to The Celtic knot and all individual donors for their contributions.

Control of the Goose Population Around the Lake

The goose control program on Lakeville Lake, initiated in 2019, was approved again for this year. When the program was started it was expected to take five years to significantly reduce the number of geese. There are two phases to the program, nest destruction/egg removal in the spring and adult round-up and relocation in the summer. Both phases were carried out in 2019. Planned activities in 2020 were cancelled due to Covid related travel and boating restrictions. Both phases were conducted in 2021. The 2022 program is being restricted to nest destruction/egg removal. EGLE has banned any adult relocation for the year due to the outbreak of avian flu in Michigan. The nest destruction phase of the program depends on receiving property owner's permission to access the nests. Based on observations, it looks like at least three nests were missed this year. Our thanks to LLPOA Board member Marc VanHoogstraat for managing the activity.

Wake/Surf Boats

If you have been following recent boating news you should be aware of the discussions surrounding wake or surf boats and their potential impact to shoreline properties. Current boating laws require 'no-wake' operation within 100 feet of the shore or any dock. Studies underway indicate that wave energy from wake/surf boats is high enough to suggest the need for greater operating distances from shore. Some studies are concluding that 'no-wake' operation for wake boats should extend at least 400 feet out. Industry experts anticipate future regulations and restrictions directed at wake/surf boats. Stay tuned and in the mean time, if you are operating a wake boat, be courteous and increase your distance to shore.
